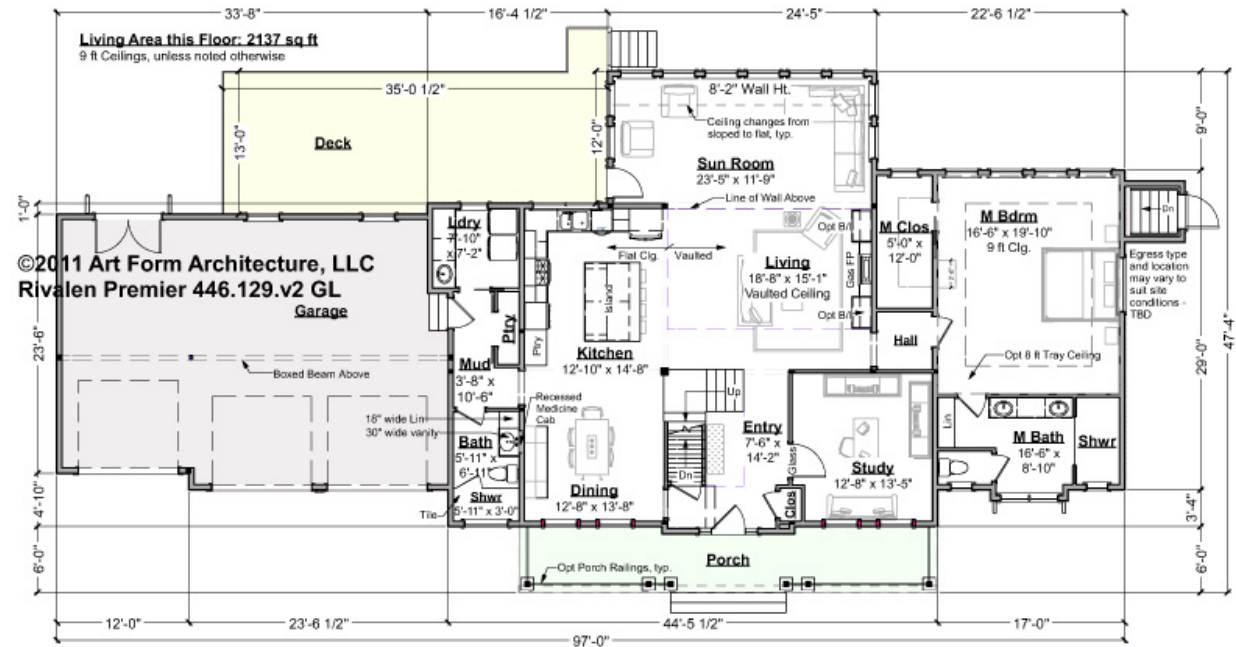

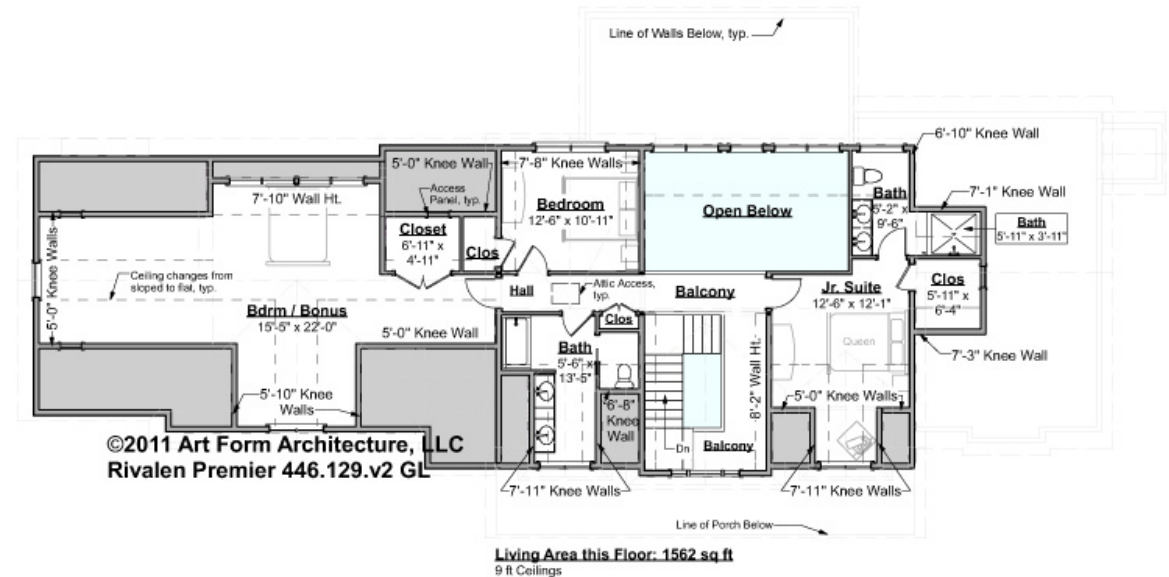
Kitchen & Sun from Living - Additional Image

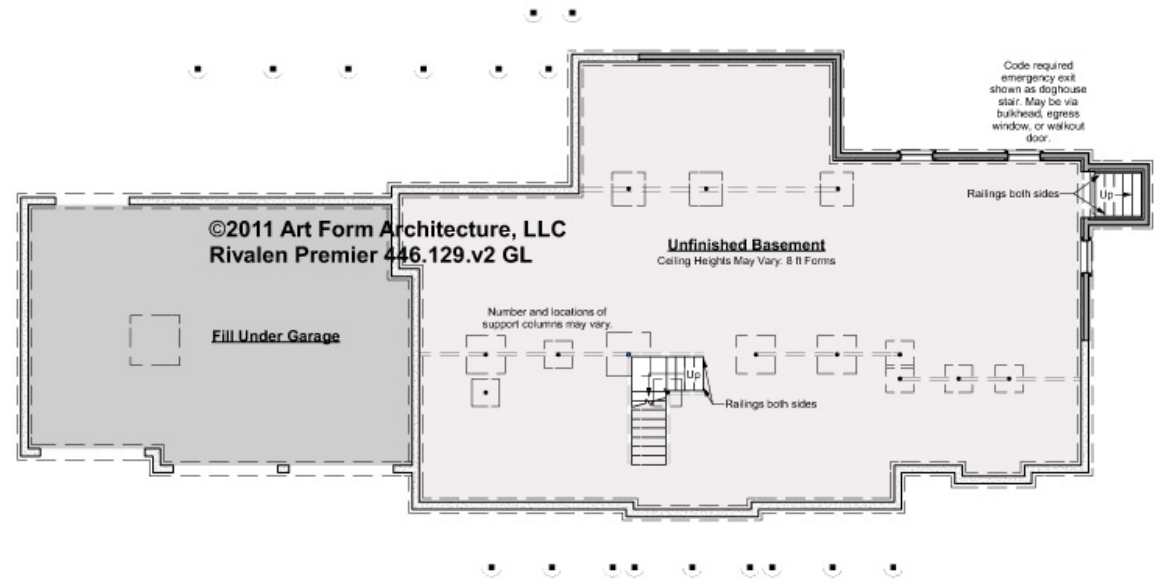
